There are only a select number of Retreats offered a year, therefore we will only hold a Retreat date when the host coordinator has completed the financial agreement and paid the non-refundable deposit of \$500.00. Half the balance must be paid 30 days prior to the Retreat with the remaining balance paid two weeks before the Retreat. Below are examples of prices based on a weekend Retreat.

This fee includes:

- 1) On going support, direction, and encouragement for the Host Coordinator which includes ideas about food, lodging, and ambiance for the Retreat
- 2) Promotional support which includes a flyer about the Retreat
- 3) A gift for each attendee
- 4) 10 hours of conference teaching and worship

Your Agreement:

- 1) A home like setting for the Retreat which can accommodate up to 50 women
- 2) Attendance/ rate commitment as delineated above
- 3) Publicity for the Retreat
- 4) Overnight lodging for Erika Baxter and Robin Crosby
- 5) Transportation for Erika Baxter and Robin Crosby to and from the airport, the Retreat location, and our lodging
